

ACKNOWLEDGMENT AND ASSUMPTION OF RISK AND RESPONSIBILITY, AGREEMENT, COVENANT NOT TO SUE, RELEASE AND WAIVER OF LIABILITY

I, the undersigned, acknowledge and agree that I know and understand the risk of climbing indoors. I am also fully aware that such climbing involves many inherent risks, dangers, and hazards, including but not limited to personal injury or death resulting from slips, trips or falls while using the Western Michigan University Student Recreation Center facilities or equipment, climbing wall, bouldering areas, landing pits, or workout area and stairs (collectively "facilities" and/or "equipment"); abrasions from or entanglement with ropes or other equipment as well as failure to participate or climb safely or within one's ability, or misuse of the facilities; failure of equipment; or injuries or death resulting from the fall of the other persons or equipment who may come into contact with myself or other persons. I am also aware that the risks and dangers referred to above exist in all aspects of climbing including the use of the facilities, or participation in classes related to physical activities or activities sponsored by Western Michigan University or other organizations. I know that injury or death could occur using these facilities or equipment. I acknowledge that I am solely responsible for my own safety and well being with respect to using these facilities.

Understanding and accepting these terms and conditions, I choose to use <u>Western Michigan University</u>'s facilities. In consideration of being allowed to use the facilities, I freely accept and fully assume all such risks, dangers, hazards and the possibility of personal injury, death, property damage, or loss resulting there from and agree to the following:
