If the Participant (or parent/guardian) and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted for arbitration pursuant to the procedures and supervision of the Rules of Procedure for Christian Conciliation, Institute for Christian Conciliation, or similar faith-based mediation and arbitration group. In the event that the Institute for Christian Conciliation ceases to exist, arbitration shall be conducted according to the rules of the American Arbitration Association.
