SESSION DESCRIPTIONS BELOW:

- 1. "Arming for Battle: De-cluttering a law office and obtaining pristine Order for the Solo practitioner or small firm". Yes, you can learn how to keep your workspace clutter-free! This program will show you how. Lawyer-consultant Meg Spencer Dixon guides an "organizationally-challenged" lawyer in the step-by-step process of "decluttering" one's desk and office. A key part of this process involves creating the following organizational tools to incorporate the key information contained in items unearthed during the decluttering process: (1) a simple but comprehensive to-do list; (2) a handy "project list;" and (3) a user-friendly filing system. This process is described in Meg's classic article "Yes, You Can Learn to Keep Your Desk Clutter-Free," which contains the chart "A Step-by-Step Guide for the Organizationally Challenged." - 2. "Proactive Advocacy with Advance Medical Directives". If your practice involves the preparation of medical powers of attorney and other types of advance medical directives, in conjunction with basic or advanced estate planning, you will not want to miss this one of a kind seminar. This session will explore vital client counseling issues associated with different types of advance medical directives. This session will discuss the legal issues surrounding the ethical, and unethical use, of advance medical directives. 3. "Handling Denial of Care Cases". This session will address legal and ethical concerns involving the withdrawal or withholding of life-sustaining medical care. Ethical issues will incorporate faith-based perspectives as well as prevailing worldviews regarding human dignity and the sanctity of life. We will discuss the legal protection of braininjured and otherwise disabled patients, citing legal precedents and specific cases. We will also address the importance of advance health care directives, as well as concerns with POLST/MOLST forms. This session will explore the procedural rules for seeking expedited redress, from the Virginia Supreme Court, in time sensitive matters such as denial of care cases. Specifically, what do I do when: (i) the patient's life sustaining medical care (i.e., food, water, anti-coagulant, cardiac medication, etc...), have been withdrawn and/or withheld, (ii) and the trial Court has just denied my request for emergency injunctive relief, and (iii) there is concern that the actions complained of will serve to speed the patient's demise without expedited relief?

- 4. "Challenging an inappropriate hospital sponsored guardianship petition. This session will explore the issues and authority involved in cases where the working relationship between a hospital patient's family, and the treating hospital, has deteriorated, and the hospital has filed a guardianship petition to appoint a non-family member or an agency to making decisions, for the patient, regarding matters such as: (i) the patient's discharge from the hospital, possibly to a geographically remote location, and (ii) the patient's future medical care and treatment to include end of life type decisions? Discover the procedural and substantive issues associated with effectively challenging an inappropriate hospital sponsored guardianship petition on behalf of an extremely vulnerable patient, or surrogate medical decision maker?

- 5. "Arming for Battle: Tracking and Projecting Law Firm Finances & Time for the Solo Practitioner or small firm". 6. "Medicaid Law: Accessing medical insurance benefits in the midst of a battle — What do I do when a patient's medically necessary care is not covered by his or her major medical insurance in a hospital setting, nursing facility setting, or home-based setting?" Discover the laws and regulations governing payment for medical care and treatment at different points along the continuum of care. Learn what types of medical care and treatment are not covered by your client's major medical insurance. Learn about frequently overlooked property exemptions, and income deductions that can be used to help your clients protect their resources while, at the same time, paying for medically necessary care, at different points along the continuum of care.
